### E-Commerce May Be New Frontier for Tribal Communities

The right of the people and self-determination is a fundamental principle in modern Indian law. This policy intended to provide, among other objectives for maximum Indian participation in the government, education of its people, and to encourage the development of its human resources as well. The policy culminated in the passage and implementation of the Indian Self-Determination and Education Assistance Act of 1975 (Public Law 93-638). The Act was intended to reverse a 30-year effort by the federal government under its preceding termination policy to sever treaty relationships and obligations to Indian tribes.

Securing the basic recognition of self-determination, for many tribes, has been a constant struggle. After surviving hostile contact with foreign governments, cultural destruction, and being subjected to aggressive foreign policies, numerous tribes have little in the way of true freedom or functioning economies.

For years, the U.S government exerted harsh control over tribes—control has left us without the traditional tax base that governments have come to rely upon. It's difficult to operate a government without



property, sales, or income taxes as a revenue source. As noted by the Hoover Institution, 20 percent of reservation households in the United States make less than \$5,000 annually. Taxes would further devastate these families.

To even develop tribal lands or allocate natural resources, Native American governments must endure seasons of bureaucratic inertia. However, one way of dealing with these unfortunate realities is for tribal governments to develop enterprises that generate the revenue needed to support vital

healthcare and education programs.

But, as the United States and California economies continue to morph into a service-based economy, tribes will need to look at other avenues to generate revenue that will support needed programs and help close the institutional gap between Native Americans and their American counterparts.

E-commerce may represent that new frontier.

I often talk with other tribal leaders; many of whom live in remote locations that see the tremendous opportunities presented by reservation-based e-commerce. Consumers of goods and services access tribe's as providers of such products via the internet. Further, such products originate on reservation subject to applicable tribal laws which govern such matters as dispute resolution procedures. Tribes, like ours, have found the internet to be the great equalizer; although remote, customers can reach us from afar via the internet. Finally, a solution that breaks down the isolation brought about by 200 years of failed Indian policy.

However, there are still significant challenges. Consumers who seek out goods and services online from tribes that wish to provide them, do so from their reservation subject to tribal law and in some instances, have been met by state and federal regulators with a burst of inapplicable regulations,

fines or legal challenges. In Connecticut, for instance, regulators sued and fined one tribe \$700,000 for engaging in e-commerce. In Missouri, several tribes have also seen significant challenges in federal courts for attempting to take their enterprises online.

Despite years of state and federal agencies outreach by tribal governments, such litigation runs afoul of good government-to-government relations and unnecessarily stalls tribal progress on becoming successfully independent through legal use of the internet. These litigious actions also further hamper opportunities for tribes to seek investment from outside investors, rightfully encouraged by Congress through the Native American Business Development, Trade Promotion and Tourism Act who could ultimately bring needed infrastructure improvements to tribal lands.

Research shows that consumers, on average, spend over two trillion dollars on e-commerce. By launching online businesses, tribes will have access to markets beyond the reach of reservations or geographical borders, and connect with customers throughout the world in meaningful ways to share our culture and participate in this new service-based economy.

My hope is that California, and eventually, federal regulators will reject this litigious posture and commit to ensuring tribes have the economic freedom to pursue what's in the best interests of their sovereign people.

# TRIBAL ADMINISTRATOR'S REPORT

3rd Quarter 2019

As we head into the second half of 2019, I can tell you much has been contemplated as well as initiated on behalf of the Habematolel Pomo of Upper Lake. It has been a year of reflection, pondering what we have lost and sacrificed in history. This year has been consumed with planning considering what we have gained and accomplished throughout the years.

July 28, 2019 marked the one year anniversary of the Mendocino-Complex fire, which unfortunately affected many Tribal Members. As a result of surviving this traumatic event, we are extremely grateful, but we must also use this experience as an opportunity to assess how we can improve from previous efforts. Not a moment has passed without doing just that. The Tribe's Executive Council and administrative staff have been meeting regularly to discuss such matters internally; working with numerous

other agencies, both tribal and non-tribal entities. Each party is interested in the same goal of being better prepared to deal with disasters such as the recent fires that plagued much of the state of California. Many concerns as well as potential solutions have been born out of these regular meetings and will become part of the Tribe's emergency response plan.

In addition to preparing for the reality of such disasters, the Tribe, its Members and the citizens of the surrounding communities have been burdened with addressing the potential effects of the proposed solution for mitigating wildfires by Pacific Gas & Electric (PG&E), which come in the form of Public Safety Power Shutoffs (PSPS). These planned power shutoffs are advertised as being able to last anywhere from two to five days in duration. This proposal has caused great concern among the Tribe and community

at large, as there seems to be no alternative being suggested and it is no longer a possibility of if, but when it will happen. The potential for the PSPSs to occur will last through fire season which ranges from early spring through the first part of November. The Tribe has participated in many community meetings to gather as much information as possible on how to lessen the various impacts these events may have on our people. To date, the top priority being conveyed to all, is to be prepared to deal with the inevitable event(s). Preparation has been the primary measure that we as a government have adopted and practiced consistently in these most recent months. Numerous checklists by various agencies including our own departments have been drafted and circulated at every opportunity. We believe that constant communication and getting the most current, up to date information to the community are vital necessities in enduring an episode such as Public Safety Power Shutoffs. The Tribe has taken the necessary steps to install a backup generator that will power both the tribal office and community building. Staff members will be available to answer questions, provide services and assist in other areas that may be needed. Emergency supplies that you will need according to the checklists being distributed; are also being compiled in the event of a worst case scenario and events lasts longer than anticipated. Furthermore, the Tribe will be installing a backup generator for the Upper Lake Rancheria pump house, which provides water for 32 homes that make up the small community residing in the boundaries of the former Rancheria. As time moves on, we are hopeful that our decisions and efforts to mitigate the impacts felt by the people

of our community and nation as they begin experiencing the public safety measures are met with success as this may become the new norm.

Although the preparation for disaster has seemed to take center stage, it is not the only step undertaken by the Tribe. The Tribe has been in the midst of preparing for the future in many capacities. In November 2018, the Tribe took a step in the direction of updating one of its key governing documents, when the Executive Council amended the Enrollment Ordinance. Additionally the Tribe has been working on amending its Constitution for several years. After recently creating and approving an ordinance to govern the Initiative and Referendum process, the Tribe is looking forward to a Secretarial Election later this year, to make an initial amendment that will allow the Tribe to exercise its sovereignty when attempting to amend the Constitution in the future.

These are just a couple of the significant matters at hand that the Tribe will be focused on in the near future. We hope the Members of the Tribe can appreciate the efforts our tribal government puts in to constantly strive and learn from the past, make decisions that have a positive effect in the future and provide opportunities for each Member to make a better life for themselves

The Habematolel Pomo of Upper Lake (HPUL) Transportation Department, headed by the Tribal Transit Driver, Vicky Hutchison (HPUL Tribal Member) administers just some of the following transit services of the Tribe that benefits the HPUL Tribal Office/Tribal Members/Parents & Guardians:

- Monthly Sherwood Valley Food Program Transits
- Tribal Member Vehicle Rental Program
- Tribal Member Transits by way of written request
- Tribal Business Transit Requests (i.e. inclusive of staff depts./ purposes & other HPUL owned entities) by way of written request
- > Vehicle Monitoring & Maintenance
- Insurance Verifications

If you're an HPUL Member, parent/guardian of an HPUL Member that needs a ride for an important appointment, or for your child/children from school to the Tribe's education center or perhaps for other HPUL tribal business purposes, the Tribe requires Members and/or staff to fill out and submit an HPUL Transit Request Form to Vicky.

### MEMBERS' TAX STATUS

If you are an Habematolel Pomo of Upper Lake Tribal Member (i.e. adult / minor) and want to know your current tax status with the Tribe please feel free to contact the tribal office and ask for the Program & Services Coordinator, Ida D. Morrison or the Fiscal Department staff to inquiry whether your tax status is under "Revenue Sharing Trust Fund (RSTF)" OR if you are "Tribal General Welfare Ordinance (TWGO)" status. Once you've determined your tax status from there you can decide whether to keep your 2020 tax status the same and/or explore your options in changing it.

Tribal Members will have the opportunity to change their tax status with the Tribe after the November, 2019 RSTF member distributions/per cap up until January 2, 2020.

## 2019 JOB INCENTIVE PROGRAM SUBMISSION DEADLINES

The JOB INCENTIVE/GENERAL WELFARE STIMULUS PROGRAM seeks to reward and provide motivation for those tribal members in the work force by disbursing quarterly payments to offset the rising cost of living for food, shelter, clothing and transportation. These costs can become very complicated for tribal members who may be transitioning into the work force as well as those who have been gainfully employed for any number of years. The program further seeks to provide limited quarterly financial assistance to those adult Tribal Members (18 years of age and up) who are legally disabled, full time students who cannot take on a job as well as those who are unemployed, but can demonstrate that they are consistently looking for employment.

### 2019 HOUSING SERVICES



Housings programs using the Indian Housing Block Grant (IHBG) from Housing & Urban Development (HUD) and are all designed for low-income applicants.

#### **Emergency Rental Assistance:**

This program is designed to assist Tribal Members who find themselves in an emergency situation without funds and needing to move A.S.A.P. Consists of the first month's rent and deposit. An emergency defined in our Policies and Procedures are as follows:

- Homeless due to fire
- Homeless due to flood
- Homeless due to unsafe living conditions
- Homeless due to renting a home that is being sold
- Homeless due to domestic violence Contingent upon attending counseling
- Medical necessity, due to severe/permanent illness or disability

#### Student Rental Assistance (NEW POLICY AMENDMENTS):

This program is designed to provide monthly income payments for full time college students for up to four years (i.e. consists of on-going monthly rents plus a one-time deposit)

- Deposit is to be returned to the Tribe upon leaving/graduating the program.
- Full time Students 12 or more units and a grade point average of 2.0 or above
- NEW AMENDMENTS consist of:
- Tribe's service area to cover entire United States and World for students studying abroad.
- Rental payment can be made to student if landlord does not accept 3rd party payments as long as proper documentation is submitted (i.e. proof of payment, notice from landlord, etc.)
- Program will cover up to \$300.00 rental assistance for students who live with parent or relative (i.e. formal rental agreement and W-9 must be submitted)
- Grade point Average (GPA) requirements are now cumulative to be consistent with amendments to Tribe's scholarship program.

#### Housing Rehabilitation Program (income based):

#### Youth Sports Program - Gymnastics:

#### Homebuyers Assistance Program (not income based):

Assists homebuyers with their deposit when purchasing a home for their family to live in.

#### Disaster Emergency Home Repair (not income based):

Assists homeowners with unexpected repairs caused by natural disasters.

#### Advanced Student Rental Assistance:

This program is for full-time students that have already utilized the Tribe's four years Student Rental Assistance Program and wish to continue with schooling for example, a Doctorate degree.

• This program has the same requirements as Student Rental Assistance.

#### Low Income Housing Energy Assistance Program (LIHEAP):

- This is a low-income based program.
- Assistance with paying energy bills.
- The elderly and families with children are to receive service first.
- The amounts received for this assistance depends on the grant award amount.

The Habematolel Pomo of Upper Lake is pleased to announce they will continue to offer its scholarship program entitled, the Seven Generations Scholarship Fund (SGSF). This funding provides financial support to qualified Habematolel Pomo of Upper Lake enrolled Tribal Members. Because we believe in the power of education, the Tribe wants to encourage our children, teens, and adults to take advantage of this opportunity to broaden their relationship to the world in the hope of creating a better life by greatly increasing their potential earning base as well as providing a solid foundation upon which to build for their families.

In addition, this fund is designed to give our Members an opportunity to enhance their knowledge and expand their experiences through further education. Whether the path leads towards a GED, higher education, vocational training, or extra-curricular activity; it is our hope that such pursuits will promote active leadership and foster self-esteem. The Tribe wants to support activities that will encourage healthy minds, balanced bodies, and caring souls. We know that this builds strong and enduring character.

Our commitment in creating the Seven Generations Scholarship Fund is about the future of the Habematolel Pomo of Upper Lake Tribe - we have a deep desire to manifest productive, responsible, positive leadership within our family; those who understand that the wellbeing of our people depends on each person's ability to give back to the community.

This fund consists of the following annual six award categories:

- 1. Higher Education: \$10,000.00 for attending a 4-year college or university & \$5,000.00 for attending a 2-year junior/community/city college
- 2. Vocational/Trade School: \$5,000.00
- 3. Adult Education: \$3,000.00 4. Youth Education: \$1,000.00
- 5. Pre-Elementary: \$500.00
- 6. Educational Electronic Device and **Peripherals** Program (if applicable based on the SGSF guidelines) up to \$1,500

Through this fund the Tribe has appointed a Scholarship Fund Selection Committee (SFSC) that currently consists of five (5) members. #### PAYOR OF LAST RESORT

The Indian Health Service (LCTHC) is the payor of last resort for persons defined as eligible for Purchased Referred Care (42 CFR § 36.61). Accordingly, LCTHC will not be responsible for or authorize payment for Purchased Referred Care to the extent that:

- 1. The AI/AN is eligible for alternate resources, or
- 2. The AI/AN would be eligible for alternate resources if he or she were to apply for them.

Alternate resources means health care resources other than those of the Indian Health Services (IHS). Such resources include health care providers and institutions, and health care programs for the payment of health services including but not limited to programs under title XVIII or XIX of the Social Security Act (i.e., Medicare, Medicaid), State or local health care programs, and private insurance (42 CFR § 36.61). Individuals requesting PRC (Purchased Referred Care) services must use the alternate resources available to them. After the alternate



resource has been exhausted, the PRC program may approve payment for approved medical services, to cover co-pay/deductible/share of cost or other amounts not covered by the alternate resource. In the case of a patient who was denied Medi-Cal for valid reasons (i.e., over income/assets), the PRC program may approve full or contract rate payment for approved medical services as long as a valid denial letter from Medi-Cal is on file and all other criteria within this policy has been met.

Individuals will be screened for eligibility for alternate resources. Those who may be eligible for alternate resources must make a good faith effort to apply for that alternate resource. Good faith effort includes, but is not limited to, submitting all required forms and documentation and attending all required appointments. It also includes submitting required documentation to maintain eligibility for alternate resources.


### Grievance Review Board Vacancy Election & Swearing In Ceremony

At the time of the July 13th meeting two 2 "interim" GRB members were determined by to the 2 highest vote getters (\*) at the time of the July 13th meeting, Vicky Hutchison and Charlene Muñoz. Thereafter, on August 3, 2019 the Tribe's Election Board conducted a presentation meeting of the GRB nominees at the Tribe's community building to give the nominees the chance to present their qualifications and to give



the members the opportunity to ask questions of the nominees.

On August 15, 2019 the Election Board attended the Grievance Review Board's monthly meeting for the purposes of the swearing in ceremony of the 2 "interim" GRB members, Vicky Hutchison and Charlene Muñoz with the rest of the existing GRB Members, Michael A. Icay, GRB Chair, Diane Jones, Ronald Obedoza, Shirley Obedoza and Arthur L. Treppa (pictured in this article). Also in attendance at the 8/15/19 meeting was the Tribe's attorney Geoff Hash with Hash Law.

On October 12, 2019, the Election Board conducted the GRB Vacancy Election from 10am-2pm polls were open at the Tribe's community building (9460 Main St., Upper Lake, CA), to all registered Member voters to cast their votes, for 2 out of the following 3 qualified GRB candidates: Vicky Hutchison, Michael Marcks and Charlene Muñoz.

### HPUL CONSTITUTION

The Habematolel Pomo of Upper Lake (HPUL) Tribe's Constitutional Review Committee (CRC) and legal team have taken the lead in proposing to amending the Tribe's Constitution.

The purpose for the proposed amendment is to protect the Tribe and all Tribal Members by increasing the election standards and voter participation required for any election concerning the amendment our governing documents. This will eliminate the current possibility of a minority group of Tribal Members changing our core documents. This protection is accomplished by removing the US Department of Interior (DOI), Bureau of Indian Affairs (BIA) election oversight and approval of amendments to the Tribe's own Constitution, and replacing that with the Tribe as overseeing and conducting any and all future elections, including those regarding constitutional amendments pursuant to our Tribal law and stringent standards.

With that said the Tribe has set up a Tribal Member webinar detailing the proposed amendments, the related processes, and the reasons why we believe they are in the best interest of the Tribe and each Tribal Member.

The Tribe is still asking for adult HPUL Tribal Members to take the webinar (that's less than 43 minutes long) and submit the following Constitutional Questionnaire form to the HPUL Tribal Office; upon doing so adult HPUL Tribal Members are eligible to receive a \$25.00 Walmart gift Card as an incentive for Members taking the time to complete and submit said questionnaire.

For more information regarding the webinar, and/ or to be given the option to view the webinar in the convenience of your home or office (day or night, at anytime), contact the Tribal Office and staff will provide you the address link / information to do so. However, upon request Members can also view the webinar onsite at the HPUL Tribal Office during business hours with the exception of holidays; for after hours or on weekends please contact the HPUL Tribal Office to set up an appointment.



### LAKE CO. FAIR


