

## TRIBAL COURT PUBLIC GUIDE TYPES OF ACTIONS IN THE TRIBAL COURT

What can the Habematolel Pomo of Upper Lake Tribal Court do? This guide provides a sample of the kinds of cases the Tribal Court can hear. These cases are based on those provisions in the HPUL Codes where the Tribal Court has a role.

- 1. Where can I find information about the Tribal Court in the Tribe's laws? You can find information about the Tribal Court from:
  - Article XII of the Constitution of the Habematolel Pomo of Upper Lake (HPUL)
  - HPUL Book of Codes (BOC)
  - Book of Codes, Title 2, Judicial

## 2. What types of cases can be filed by a tribal member?

- Enforcement of Judgements
  - (a) Garnishment Recognition of valid orders. [Garnishment Ordinance, BOC 2-2, Sections 4-V(A); 4-VI(A); and 4-VIII.]
  - (b) Business Corporation enforce shareholder demand to pay. [Business Corporation Ordinance, BOC 5-1 Section 1-8.28.7.]
  - (c) Business Corporation Enforcement of judgment, forced share sales. [Business Corporation Ordinance, BOC 5-1, Section 1-11.10.2.]
- Child Welfare Matters
  - (a) Modification of parental rights, termination of parental rights, guardianships, adoptions, appeals. [Children and Families Code, BOC 4-1].
- Civil Claims
  - (a) Business Corporation Civil protection order. [Business Corporation Ordinance, BOC 5-1, Sections 1-8.24.5; 1-8.24.6.; 1-11.10.1; 1-11.11; 11.13.1; and 1-11.14]
  - (b) Business Corporation Individual claim. [Business Corporation Ordinance, BOC 5-1, Section 1-8.26.]

- Appeals from Government Decisions: the following Acts provide for appeals from certain government decisions to the Tribal Court:
  - (a) Code of Ethics Ordinance: BOC 1-4
  - (b) Children and Families Code: BOC 4-1
  - (c) Garnishment Ordinance: BOC 2-2
  - (d) Election Appeal of Removals by EC: BOC 1-1
  - (e) Initiative and Referendum Appeal of petition rejections: BOC 1-2
  - (f) Enrollment EC decisions be reviewed in tribal court: BOC 1-3

## 3. What laws might apply to a case filed by the Habematolel Pomo of Upper Lake government?

- **4.** Children and Families Code: Modification of parental rights, termination of parental rights, guardianships, adoptions, appeals. [BOC 4-1]
- Election Ordinance: Removing a Tribal Officer from Office: [BOC 1-1].
- Enforcement of Violations of Tribal Law such as:
  - (a) Liquor/ABC License Violations [BOC 5-3]
  - (b) Animal, Fish and Fowl Ordinance [BOC 3-1]
  - (c) Business Corp Violations of the Business Corporations law. [BOC 5-1]
- **5. Is this list current?** Although every effort is made to keep this list updated, please note that current law can change, and new laws can be enacted that could increase the types of cases the Tribal Court can hear. You should always check tribal law first under the "Tribal Law" section of the "Government" tab on the Habematolel Pomo of Upper Lake website.
